### DISCUSSION FROM THE FLOOR

- \*\* Limited to 3 minutes per person to state their concern.
- \*\* Action: Council direction to staff for resolution or take this matter under advisement for action at the next regularly scheduled meeting.

### PUBLIC HEARINGS

Advise audience that the purpose of the public hearing is to receive citizen input on the proposal to (name of project). (This is not a time to debate the issue.)

The following format will be used to conduct the hearing:

- \*\* The presenter will have a maximum of 10 minutes to explain the project as proposed.
- \*\* Councilmembers will have an opportunity to ask questions or comment on the proposal.
- \*\* Citizens will then have an opportunity to ask questions and/or comment on the project. Those wishing to comment are asked to limit their comments to 3 minutes, except in cases where there is a spokesperson representing a group wishing to have their collective opinions voiced. - \*\* People wishing to comment are asked to state any new facts they may have within the 3 minutes allotted. Please be specific and to the point.
- \*\* Everyone will be given the opportunity to express their agreement or disagreement even if they have no new points to make. (This is not a time to debate the issue.)
- \*\* People wishing to speak twice will be given 2 minutes to comment on any new facts brought forward since the last time they spoke.

Following public input, the Council will have a second opportunity to ask questions of the presenter and/or citizens.

The public hearing will then be adjourned with the Council taking the matter under advisement until the next regularly scheduled Council meeting. At the next regular meeting, the Council will debate the issue, if necessary, state their positions and make a decision. NO further public input will be received at that time.

Pursuant to due call and notice thereof, the regularly scheduled meeting of the Spring Lake Park City Council was held on March 5, 2018 at the Spring Lake Park Community Center, 1301 81st Avenue N.E., at 7:00 P.M.

### 1. Call to Order

Acting Mayor Nelson called the meeting to order at 7:00 P.M.

MOTION BY COUNCILMEMBER WENDLING TO APPROVE THE CONSENT AGENDA. ROLL CALL VOTE: ALL AYES. MOTION CARRIED.

### 7. Code Enforcement Report

Building Official Brainard reported that he attended the Council meetings on February 5 and February 20; an Employee Safety Training on February 28; the ICC Region III Educational Institute on February 12-16; the North Suburban Building Officials meeting on February 27; and the Planning Commission meeting on February 26.

Mr. Brainard stated that in February 2018, eight building permits were issued compared to 12 in 2017. He reported that seven mechanical permits were issued in February, compared to 10 in 2017. He reported that six plumbing permits were issued and no zoning permits were issued in February 2018.

Mr. Brainard reported construction on the School District #16 Early Childhood Addition and Renovations at 1415 81<sup>st</sup> Avenue has recently commenced. He reported that a demolition permit was issued for Substance Church for the construction of removing existing inside walls for the future construction of additional classrooms and conference rooms.

Mr. Brainard reported that on February 13, 2018, he received the 2017 Code Enforcement Official of the Year award by the Association of Minnesota Building Officials at the International Code Council Regions III conference. He thanked Permit Technician, Kristine Pearson, for nominating him the award.

Mr. Brainard reported that the February 2018 vacancy listing shows that there are 17 vacant/foreclosed residential properties currently posted and/or soon posted by the Code Enforcement Department, which is down two from last month. There are two vacant/foreclosed commercial property, which is remains the same from last month; and five residential properties currently occupied and ready for Sheriff Sale redemption, which is down six from last month. He reported that he did not post any abandoned and/or vacant property notices in month of February; in addition, ten Administrative Offense Tickets were issued by the Code Enforcement Department. He noted that nine of the Administrative Offense Tickets were issued for failure to register rental property for 2018 and have a \$100 administrative fee.

Acting Mayor Nelson congratulated Mr. Brainard on his award and for his hard work and dedication to the City.

#### 8. Ordinances and/or Resolutions

##### A. Ordinance No. 446 Amending the Spring Lake Park Zoning Code Regarding Commercial/Industrial Parking or Loading Facilities Setbacks; PUD Requirements

Administrator Buchholtz reported that City staff has received inquiries from commercial/industrial property owners about parking lot setbacks. He stated that the setback language is unclear as it is not listed in a performance standard table within Appendix E and is only partially listed within Section 153.132 of the Zoning Code.

Administrator Buchholtz reported that in order to clarify the parking setback standards for commercial and industrial districts within City Code, staff has drafted an amendment to the City Code adding parking lot setbacks to Section (B) of Appendix E.

Administrator Buchholtz stated that the parking setbacks are generally consistent with the existing City Code, with the following exceptions:

- Staff has established a new front yard setback for the commercial districts at 25 feet. The current code could be interpreted to read that parking would not be allowed in front of the existing front yard setback of 40 feet, which would be a hardship and inconsistent with land uses across the City. The 25-foot front yard-parking setback is also a standard setback in many communities around Spring Lake Park.
- The side and rear-parking setback was 15 feet in the I-1 district, with the exception of when a parking lot is adjoining another parking lot. Then, the setback would be zero. The proposed ordinance establishes the setback at 10 feet normally, and 20 feet when the parking lot abuts a residential property. This is consistent with the commercial districts. In addition, the zero setback provision would be repealed.

Administrator Buchholtz reported that with the setback language in Appendix E, Code provisions 153.132(B) and (C) will be repealed.

Administrator Buchholtz stated that Section 3 of the Ordinance corrects a reference error in Section 152.151(B)(1) of the City Code.

Administrator Buchholtz reported that the Planning Commission, after holding a public hearing on the proposed ordinance, recommended approval.

#### 9. Engineer's Report

Engineer Gravel reported that he has been working on plan reviews and working with Public Works Director Randall on water system reports. He reported that the dredging of the pond at Triangle Park is complete. He stated that the project went well and research is being done on plantings to be placed around the pond to keep the geese away and to create a visual barrier. He noted that the samples from the pond did not show any contaminants complied with the Minnesota Pollution Control Agency requirements.

#### 10. Reports

##### A. Beyond the Yellow Ribbon Report

Acting Mayor Nelson reported that 62 meals were served at the February pork chop dinner. He reminded residents that the Beyond the Yellow Ribbon business meeting will be held on March 13, 2018 at 6:00 PM and he encouraged any residents to attend who would like to volunteer with the committee.

#### 11. Other

##### A. Administrator Reports

Administrator Buchholtz reported that he accompanied Building Official Brainard on an inspection at the Dominion project. He stated that the building is progressing nicely. He reported that Dominion has held open houses the past few weeks and 24 leases have been signed.

Administrator Buchholtz reported that the Sunset Grill is making progress on the remodeling of the restaurant. He stated that the new furnace in the basement has been installed and the rooftop units were to be installed in the next week.

#### 12. Adjourn

Police Report

February 2018

Submitted for Council Meeting – March 19, 2018

The Spring Lake Park Police Department responded to five hundred and twenty-two calls for service for the month of February 2018. This is compared to responding to four hundred and forty calls for service in February 2017.

Investigator Baker reports handling a case load of twenty-nine cases for the month of February 2018. Twenty-two of these cases were felony in nature, one of these cases were gross misdemeanor in nature and six of these cases were misdemeanor in nature. Investigator Baker also continues to monitor six forfeiture cases along with his other cases for the month. Investigator Baker noted a case from February, where Spring Lake Park Officers were called to the 8000 block of Old Central Avenue regarding an attempted rape of a juvenile victim. Spring Lake Park Officers arrived and conducted an investigation into the incident. A person of interest was located and taken into custody. The investigation was turned over to the Anoka County Sheriff's Office Criminal Investigation Division. The person of interest has been charged with Kidnapping and 1<sup>st</sup> Degree Criminal Sexual Conduct. At the time of the writing of this report the person of interest was in custody at the Anoka County Sheriff's Office Jail with a bail amount of \$600,000. For further details, see Investigator Baker's attached report.

Our School Resource Officer, Officer Chlebeck reports handling six calls for service at our local schools for the month of February 2018, along with conducting twenty-seven student contacts, nine escorts and nine follow up investigations into school related incidents. Officer Chlebeck did indicate that he did participate in a "School Lockdown" drill during the month as well as attending the County Wide School Resource Officer Meeting and a "Circle Meeting" with the Restorative Justice Program of the Anoka County Attorney's Office Juvenile Division. Officer Chlebeck was also able to do a presentation to the 12<sup>th</sup> grade AP Government Class on "Constitutional Amendments". For further details see Officer Chlebeck's attached report.

The Spring Lake Park Police Department Administrative Office Staff continue to remain steadfast in their duties, typing and imaging reports, filing, answering and dispensing phone calls for service and information, while continuing to address citizen concerns at our "Police Public Walk up- Window", along with other duties that may be assigned on a daily basis.

The month of February has been a busy month for myself as well, besides handling the day to day operation of the police department. I continue to attend meetings on a daily basis representing the City of Spring Lake Park and the Police Department. These meetings include but are not limited to:

- City Council Meetings held here at city hall for the month
- Department head meeting held here at city hall
- Anoka County Chiefs of Police Monthly Meeting held in Coon Rapids, MN.
- Conducting Meetings with future potential towing service providers
- Meeting with our IT Company regarding computer issues and updates

I concluded the month by attending our annual "Aware Training" for all city employees per OSHA requirements held here at City Hall.

**MS4 Permit (193802936).**

*Annual report and annual public meeting will be completed in June (Annual report due June 30<sup>th</sup>).  
Annual Training will be completed in the fall.*

**Surface Water Management Plan (193803949).**

*Detailed storm water modeling has been completed. We are currently using the storm water model to evaluate proposed conditions to see what can be done to reduce flooding in these areas. We have met with Terry to discuss preliminary results. Staff will also meet with property owners on the south end of Terrace Rd. to discuss possible ponding options.*

**2017 Sanitary Sewer Lining Project (193803782).**

*This project included sanitary sewer lining in the neighborhood east of Able Street and north of 81<sup>st</sup> Avenue. The Contractor was Visu-Sewer. Terry Randall is working on follow-up items.*

**2018 Sanitary Sewer Lining Project (193804547).**

*This project includes sewer lining in the northeast area of the city. We are currently preparing construction plans and will solicit bids late this spring.*

**2017-2018 Street Seal Coat Project (193803783).**

*This 2-year project includes street maintenance in the neighborhood north of 81<sup>st</sup> Ave. and west of Monroe St. (2017) and in the neighborhood east of Monroe St., south of 81<sup>st</sup> St. and west of TH 65 (2018). Terry Randall will coordinate 2018 work this summer.*

**Wells 4 and 5:** *Working with Terry on a process for rehabbing these wells. The timeline for rehabilitating the wells will be late summer for Well 4 and autumn for Well 5. That way a driller can start on Well 4 and, when done, can move to Well 5. The rehab bids will be more competitive if the work on the wells can be scheduled this way, as it will keep a well rig busy for an extended period.*

**Wellhead Protection Plan:** *A well survey was mailed to residents in February. Once the surveys stop coming back, information from the returned surveys will be compiled. The results of the survey, along with other wellhead protection activities in the past two years, will be included in a Plan Evaluation Report which will be provided to the MDH. At that time, a letter requesting the 10-year extension to the Plan will also be provided. This is anticipated to be sent in April or May.*

**Other issues/projects.**

3.21.18 Technical Advisory Committee (TAC) meeting for the Coon Creek Watershed District.

Working on getting water level information to complete the Water Supply Plan (DNR requirement).

Working with cellular companies (Verizon and AT&T) regarding facilities on the water towers.







# Curbside Organics Collection Now in Fridley

Organics Collection = Less Waste, New Jobs, Valuable Compost

Similar to recycling bottles and cans into new, useful materials, organics collection does the same by transforming everyday waste like food scraps and paper towels into soil compost (which in turn helps grow more food and the cycle continues).

Now it is easier than ever to be part of the solution with curbside organics collection.

**What are organics?**

- All food scraps (fruits, vegetables, meat, fish, bones)
- Dairy products
- Eggs, eggshells and paper egg cartons
- Coffee grounds and filters
- Food-soiled paper napkins and paper towels
- Facial tissues
- Pizza boxes
- Animal and human hair
- Cotton balls and cotton swabs (without chemicals)
- Wooden sticks (popsicle, toothpicks, chopsticks)
- Certified compostable plates, cups, utensils and bags

That is a lot of items out of your garbage—you might need a smaller garbage cart!

**What is curbside organics collection?**

Similar to your curbside recycling, you collect organics in your home (in compostable or paper bags), place your bagged organics (plus pizza boxes and egg cartons) in your organics cart, and take it to the curb in time for weekly Wednesday collection.



**What does it cost?**

This is a voluntary program. For those who sign up, it will cost \$10/month and billed every 90 days by the service provider, Republic Services. This cost includes weekly collection, a free 30-gallon organics collection cart, and free kitchen pail and compostable bags while supplies last. Kitchen pails and compostable bags, will be available for pickup at Fridley City Hall or Springbrook Nature Center during normal operating hours.



## The Power of Play

It is more than just a game. It is about impact, making a connection, relating to kids on a stronger level. The Police Activity League is about more than play; it is about making a difference.

Several of Fridley's officers are hometown grown – they learned in Fridley schools, played in our parks, attended civic events, and have a deep connection to the community. For these officers, mentoring is especially meaningful and an essential part of why they choose to serve.

"I was born and raised in Fridley. I went to Fridley High School," says program leader Officer Patrick Faber. "I had great role models, especially Fridley officers active with the schools, and I want to pay that forward. It is important kids see us as normal people, not robots, and not in the negative light media often portrays. We are doing very positive things."


Efforts such as Safety Camp, Arrive Alive, the Police Explorer Program and School Resource Officers have seen tremendous results over the years. Last spring, officers continued that trend with the launch of the Police Activity League (PAL).

"Kids can change the world, and that includes the problems and attitudes in law enforcement today," says Faber. "The more open we are, and the more kids get involved, the brighter the future will be for us all."

PAL saw a huge response from day one. Officers traded their uniforms for coaching whistles and joined 50 middle school students on the court. It started with basketball, then soccer, and will continue to grow with a variety of activities. In February/March they developed teamwork in various gym games, went out for pizza and a movie, learned to play pool and even showed off mad skills during a talent show. Always side-by-side—kids and officers.

Funding for PAL is provided by the Police Department's drug and alcohol forfeiture funds, and it is a collaborative effort between Fridley Police, recreation staff and the Fridley School District. The goal is to encourage team building, foster positive relationships, and open discussions on difficult subjects that affect today's youth.

### Build a Home Emergency Kit

- Bottled water – a gallon per person is recommended
- Non-perishable food – soups, stews, canned pasta, things that do not require refrigeration
- Flashlight and spare batteries
- Whistle – in the event that you become trapped, a small whistle can signal help
- Basic set of household tools
- First aid kit
- Dust masks
- Plastic garbage bags – good for a number of uses including waterproof covers
- Battery powered radio

The idea is to have enough supplies on hand for a couple days in a place that is easy to grab in case of an emergency.



## From the Director


An interesting and somewhat rare opportunity fell in our laps as an organization the other day: to become a pilot site for a brand-new collections software that will link local history groups throughout the state.

## LIVING LEGACY:

What better memories than that of a warm kitchen belonging to a bustling grandmother holding a cookie sheet in her hand, filled with doughy blobs and melted chocolate? Or perhaps frying fish, fresh caught that afternoon and filleted by the skilled hands of a grandfather? Or those special holidays where a tattered cookbook or recipe card saw the light of day once more, only to receive another splash of oil or dash of flour over the handwriting...but no matter because the tradition had become so ingrained, the memory brought forth the ingredients?

Who are you? Where do your people come from? How long have you been keeping traditions alive? Interestingly, America has become a place for historic cooking methods and recipes. Our immigrant ancestors came from a variety of homelands, packing their most cherished belongings and cooking traditions in trunks and suitcases. They proceeded to teach us how to cook, one generation at a time, and we didn't alter the recipes substantially. But those who remained in the homeland sure did! Those who venture overseas in search of relatives (both dead and alive) discover variations of familiar recipes, since the old ways have disappeared there.

According to the *Food Timeline* by Lynne Olver, "every group of people who settled in American contributed something special from their traditional cuisine to our national 'melting pot'."

She goes on to explain the impact of culture on American food is really a study in the original location, immigration patterns, economics and labor, adaptation, and business. In 1913, Ellis Island claimed to be the world's largest restaurant, serving detained immigrants a variety of foods, some familiar and some more surprising, including stews, white bread, and bananas. According to *Ellis Island Immigrant Cook Book*, by Tom Bernadin, these individuals could also purchase a box lunch of sausages, sandwiches, and fruit to take with them on the next leg of their journey.

Some recipes, like Schupfnudel, or Fingernudel, in German culture, tell a story before they even crossed the ocean to America. This “finger noodle” or thick dumpling, originates in the southern portion of the country, as well as Austria. It’s internationally known as Italian Gnocchi, yet takes on a few additional twists when it reaches the Scandinavian countries. Comprised mainly of flour and egg, finger noodles can also contain potatoes, if the vegetable had come to be grown in the region. The dough is rolled between the palms to form a snake-like shape, then fried in salt water or oil. Again, depending on the region, these noodles may be served as part of the main course with sauerkraut or sage and butter, or as a dessert dish with poppy seeds, sugar, and cinnamon. As this recipe travelled Europe, it even became part of festivals, served with fruits like apples and pears.

Waffles present another recipe that has shifted form as it travelled the world, reinventing itself as new ingredients became available or cooking methods changed. The breakfast item we trust to appear next to bacon on Saturday mornings generally comes either square or circular, depending on the iron used. Without the special iron to imprint the squares to catch the syrup, really...you’d just have a pancake. The Belgian waffle we know in America has dozens of cousins back home, extending through history to the Dutch and even French, as far back as 1100. Taking its origins from the communion wafer of the Roman Catholic tradition, the batter originally contained no leavening agent, though still received its shape from being pressed in a round iron. By the 16th Century, however, the deeply grooved pattern had emerged in art depictions of the food and by the next century, recipes giving specific proportions of ingredients were available. The first legislation regulating the establishment of bakeries occurred in 1560 by Charles IX, King of France.

In 1830, Belgium, a small but heavily populated country bordering on France, Germany, and Luxembourg, detached itself from the Netherlands and became an independent nation. The traditional Brussels waffle has a light texture and taste that comes from the yeast-leavened batter they are made from. They were introduced at the 1964 World’s Fair in New York City and were sold as “Bel-Gem Waffles,” which


catapulted them to popularity in America. One notable difference between the American style Belgian waffle and the Brussels waffle is the use of baking powder versus yeast, giving it a different texture and taste.

When compared with the Brussels style waffle, Liege waffles tend to be denser, a bit chewier, and sweeter, the dough more closely resembling a brioche style bread. Liege waffles are believed to

have been developed by Liege's Prince-Bishop's chef back in the 18<sup>th</sup> century. The signature element on a Liege waffle is pearl sugar, which comes from sugar beets, which caramelizes and sweetens when baked. A Liege waffle served fresh from a street vendor will have hot sugar and crispy edges that melt in your mouth.



Sometimes recipes evolve based on the needs of consumers more so than the ingredients available to the cook. Think, for instance, of the coal miners in Wales or the iron ore miners in northern Minnesota who relied on a meat-filled pastry with a sturdy crust to act as a handle for their work-worn hands at lunchtime. They would often come home to another type of filled pastry food...fruit pie.

The America Pie Council estimates that grocery stores sell \$700 million in pies each year. That doesn't include restaurants and bakeries' sales, or those cooked at home. It also reports that the flavor favorites (after apple!) are: pumpkin, pecan, banana cream, and cherry. Just for fun, check out your "pie personality" on this page.

The collection of cookbooks held at ACHS preserve the type of comfort foods held dear by Anoka County residents. Mostly comprised of church publications, other organizations like 4-H and Anoka Halloween have also published their own books. What to do with common home garden plantings like rhubarb (or pie plant) and zucchini that grow abundantly fill many pages, as do potato dishes and a variety of meat-based meals. After WWII, when convenience foods became more available on

grocery store shelves, the recipes changed to include these items. Here, suggestions for Jell-O fruit salads, Campbell's Soup bakes, Rice Krispy bars, and even Velveeta fudge, became common.

What food traditions still live on in Anoka County? What makes your family special? What legacy comes to you through your cookbooks and recipe cards? Oh, and just in case you want to revive Velveeta Fudge—we've printed it here.

1 pound Velveeta cheese  
 1 pound margarine  
 1.5 cups of cocoa  
 4 pounds powdered sugar  
 1T vanilla  
 chopped nuts optional

Melt Velveeta and margarine in microwave until blended, stirring every 1-1.5 mins. Mix in remaining ingredients, pour into buttered jelly roll pan. Freezes well.

We are fortunate to have here at ACHS many items that, while not unique to the county, still help us to tell the story of Anoka County citizens and connect us with the larger story of the United States. A good example of this comes from a donation of cameras that we received in 2016. The fact that a local family purchased and used this equipment gives us good information about how national camera trends and manufacturers were relevant here.


The Johansen family of Anoka donated several Kodak brand cameras, which start with the Kodak Duaflex III (manufactured 1954-1957) and end with a Kodak FunSaver Weekend 35, a plastic-encased, disposable camera dated to the late 1980s to early 1990s. The Duaflex III is a “twin lens” camera (see above), which operated by opening a flap in the top so that the photographer could look down into the camera to see what they were about to photograph. This model is an interesting contrast to the viewfinder window that requires the photographer to hold the camera up to their eye to see the shot.

Another interesting camera from the Johansen family is the Kodak Colorburst 100 (manufactured 1978-1980, see below). If you have visited the *Farms to Flamingos* exhibit here at the museum, you have probably seen our 1978 Polaroid camera, famous for its “instant film” that could be pulled out of the camera and developed as it was exposed to air. The Colorburst 100 was Kodak’s version of an instant film camera, and the Johansens also donated the instruction manual and an unopened box of film that goes with it; a complete set. Kodak did not manufacture these cameras for very long, as they were successfully sued by Polaroid for copyright infringement starting in 1981.

Disposable film cameras, not unlike the Kodak FunSaver Weekend 35, are still readily available today, in spite of the prevalence of cell phone cameras. These cameras come pre-loaded with a roll of film, and when all the pictures have been taken, the whole camera goes to a photo shop so the film can be extracted and developed. Some are marketed specifically for use at weddings, and plastic-encased versions are aimed at travelers, just as they were when they were invented.

These cameras illustrate the variety of devices used during the suburban era and later.

## FEDERAL BRUNCH RECAP



### GENERALLY SPEAKING, ACHS RAISES FUNDS FOR VETS PROJECT

Nearly 100 people gathered at the Federal Premium clubhouse in Anoka to enjoy a brunch meal served by Wells Catering and hear high-ranking military officials tell their stories.

The morning began with socializing, as guests explored the historic building. Displays depicting Federal Cartridge's production during WWII and items denoting the more recent conflicts in Iraq added a historic element to the event. Memorabilia from Vietnam Veteran Sam Hermanstorfer reminded those in attendance that our time is fleeting. Unfortunately, two military funerals were held that same day.

After a welcome by ACHS President, Orville Lindquist, the Anoka American Legion Post 102 presented the Honor Guard. Next, Lieutenant Colonel Lori Allert recounted her experiences during Desert Storm, saying at one point, they didn't know how long they would be activated.

"Indefinite," said Allert. "That word hit us like a hard punch to the gut. Our countdown calendars that we had started were now meaningless and thrown away. We wondered if we would be gone for years like soldiers in WW2. How will our families cope with this? Will they wait for us? How will we endure working 12-hour shifts 7-days a week for that period of time?"

Allert has served 27 years in the Army with deployments to Germany and Kuwait. She completed reserve overseas training tours in Germany, Korea, and El Salvador. Allert works as a Small Group Leader for Command and General Staff Officer's Course and a VA clinic nurse.

Major General Jon Trost retired after serving over 40 years, beginning with his draft during Vietnam. He taught at Coon Rapids High School during his military career, in the Industrial Arts department.

"The Army is about soldiers and

family,” said Trost. “When you boil it down, that’s what’s really important.”

Trost related his experience with the draft, which led to his career with the National Guard.

“I came back from a basketball game during the lottery for the draft [in 1970] about a quarter of six and saw my name on the fridge,” said Trost. “I was number 21. I got a beverage out of the fridge and called my Dad. He said to go to the National Guard Armory in the morning and get on the waiting list. From there, whichever door opened was where I was going.”

This letter is intended to finalize the conditions from the City Council approval for the Early Childhood Center located at 1415 81<sup>st</sup> Avenue Northeast.

Fencing

Fencing has been added to the drawings to be provided by the contractor at the play area. See attached revised drawing C1.21 and C2.12.

Lighting

We intend to reuse the existing site lighting on the site. We have conducted a light meter test and found the average level of the existing lighting to be 1 foot-candle. The US Department of Energy recommends an average of 0.5 foot-candles as a standard for parking light lighting. As such, we believe the existing lighting on the site will be more than adequate for the proposed use. See attached for the light meter test results.

Cross Walk Striping

Cross walk striping and signage has been added to the parking lot area to help create a safer environment for pedestrians. See attached revised drawing C1.21.

In addition, we will be working with the Rice Creek Watershed to obtain the maintenance agreement and we will forward a copy to you as soon as it is complete.

At this time, we believe we have satisfied the conditions on the approval from the City Council. Please confirm if you are in agreement that the conditions have been met or please advise if additional information is necessary.

We look forward to working with you on this project.



There are three categories of programs that are scheduled on the City channels; live and replayed meetings, NMTV staff created video content, and informational graphics pages. All categories of programming must be encoded, scheduled, and entered into the Tightrope playback system or entered into the Carousel video files.

Meetings are scheduled for replay based on schedules requested by each City. Additional longer-length video programming produced by NMTV staff is also scheduled on the channels. **With the arrival of the Carousel units, shorter-length videos and promos are loaded onto those devices, rather than being scheduled as separate playbacks. The short videos cycle through, with graphics pages, and play on the channels whenever a scheduled program is not playing. Depending on whether a City selected the split screen or full screen Carousel option, the shorter videos are cycling 24 hours a day.** The table below outlines how many times a longer-length video program was entered into the Tigtrope system, and played back on each City channel.

## Meetings on Demand



NMTV has created a video on demand service, with line-item bookmarking, for our Cities meetings. In order to accomplish this, each encoded meeting has to undergo several steps. The meeting must first be transferred and transcoded from the playback server to the video on demand server. The length of time necessary for this varies based on the length of the meeting and whether it is recorded in SD or HD. Once that is done, a staff member must go through the meeting entering a bookmark at the start of each meeting line-item, and type in the corresponding line-item information. Staff utilizes marked agendas provided by City staff members for this step. If marked agendas aren't provided by City staff we go to the City website to find unmarked agendas and place the meeting on VOD without bookmarks. Once that is done and saved the bookmarked meeting is then linked to the NMTV website's city meeting page for video on demand.
