A Message from Code Enforcement

Summer is here, and that means it's time to keep Spring Lake Park looking great! The City relies on your help to maintain clean, safe neighborhoods. Below are some seasonal reminders, helpful tips, and important information from the Code Enforcement Division.

Per City Code, grass and weeds must be kept under eight (8) inches. Properties not mowed may be subject to abatement and fines. Please keep your lawn trimmed, including ditches and boulevards if applicable.

🕅 Trash, Debris, and Outdoor Storage

Keep yards clear of:

- Trash and loose debris
- Old furniture, appliances, or building materials
- Tires or junk vehicles

Outdoor storage of these items is not allowed unless kept in a fully enclosed structure.

🚙 RV, Boat, and Trailer Parking

As summer recreation picks up, remember:

- RVs, trailers, and boats must be parked on a approved driveway (not grass).
- They must not block sidewalks or overhang into the street.
- Long-term street parking may be limited by ordinance and signage.

A Permits for Summer Projects

Planning to build a deck, fence, shed, driveway, or patio? Many summer projects require a building permit.

Check with the Building Department before starting work to avoid penalties or delays.

🔆 Solar Panel Caution

We've seen an increase in solar panel permits. Please use caution if approached by door-to-door solar sales companies.

♦ No peddler licenses have been issued for door-to-door sales in Spring Lake Park.

 \checkmark Verify contractors are licensed and approved before signing anything.

Tree & Shrub Maintenance

Please trim trees and bushes back from:

- Sidewalks and alleyways
- Street signs and intersections
- Utility poles and streetlights

This helps maintain visibility and safety for drivers and pedestrians.

Maintenance Matters

Simple upkeep like painting, fixing gutters, or repairing fences keeps our neighborhoods strong. If you're planning improvements and aren't sure if you need a permit—just ask!

Reporting Concerns

Spring Lake Park is a <u>reactive</u> code enforcement city, which means complaints are responded to as they come in. We rely on residents to report concerns.

By following City ordinances and maintaining your property, you help keep Spring Lake Park a safe, clean, and welcoming community for all. Thank you for doing your part!











Your Spring Lake Park - Blaine -Mounds View Fire Department, Today and Tomorrow

Since January 2024, the (SBM)

Spring Lake Park – Blaine – Mounds View Fire Department has undergone major and historic changes since our inception in 1944. In an effort for service, we are now staffing our response district 24 hours a day, 7 days a week, all year long with a highly trained Duty Crew. This has made a significant life-changing impact on our community residents, as well as our response times arriving to calls for service.

SBM is proud to say that we have reduced response times by more than three (3) minutes from our old volunteer response model. You may ask, does three (3) minutes really make that much impact? We say, YES! A fire doubles in size every 30 seconds if left to grow. Three (3) minutes of arrival at a cardiac arrest, heart attack, or medical call increases the chances of us making a medical difference to those in need. Those three (3) minutes have already saved lives, property, and made a difference for our community as a whole.

Lastly, this new staffing model has helped us reduce wear and tear on our apparatus, increase the turnout of firefighters on scene for each call, and reduce the fire loss to the community. This change has also affected the budget in a positive way allowing us to reduce costs with the mantra of "leaner and meaner." As we look towards 2026 and beyond there will be continued advancements within the department as we continue to focus on operating more efficiently, responding quickly, and adapting to our changing communities we proudly serve.

Potting Soil Fire Safety

Potted plants are not ashtrays! When a cigarette is put out in the dirt of a potted plant, the soil can work to insulate the lit cigarette, heat the soil to an ignition temperature and begin to smolder. These types of fires can often smolder for several hours and when enough oxygen is available, the materials will break out into flames. If the planter is located near other combustible items like a deck, side of a house or fence, they may become involved resulting in a serious fire. If you're a smoker, please keep your "butt" out of the dirt and use a sturdy, metal ashtray to properly extinguish the smoking materials.

Change to the Parking Restrictions Ordinance

A change has been made to the Parking Restriction Ordinance. Ordinance 7.08.020 D(2) now reads:

"No vehicle shall be parked within ten (10) feet of either side of the curbside mailbox, as measured along the edge of the roadway or curb line, between the hours of 8:00 AM and 6:00 PM, Monday through Saturday, except on federal holidays when mail is not delivered. This restriction is intended to ensure unobstructed access by authorized mail delivery vehicles."

Curfews for Juveniles

The City of Spring Lake Park and neighboring communities share and enforce the same curfew hours for all minors. Spring Lake Park Ordinance 13.04.050 states juveniles under the following ages may not be in a public place without direct parental or guardian supervision:

Under the Age of 12

- Sunday Thursday: 9:00 PM to 5:00 AM
- Friday and Saturday: 10:00 PM to 5:00 AM

12 to 14 Years of Age

- Sunday Thursday: 10:00 PM to 5:00 AM
- Friday and Saturday: 11:00 PM to 5:00 AM

15 to 17 Years Age

- Sunday Thursday: 11:00 PM to 5:00 AM
- Friday and Saturday: 12:00 AM to 5:00 AM

Firework Safety

July is National Fireworks Safety Month. Here are some safety tips when dealing with fireworks. Also remember that not all fireworks are legal in Minnesota. Check out the following State Fire Marshal's page for more information on what is legal and what is not by visiting *dps.mn.qov/divisions/sfm*.

Firework injuries have been on the increase in recent years, accounting for 9,500 emergency room visits and 24,000 fires annually. Children ages 14 and under are most vulnerable. The misuse of fireworks, frequently by unsupervised children, accounts for the majority of fireworks injuries.

- Children account for approximately 47% of those who receive emergency room treatment of firework-related injuries.
- Burns are the most common type of firework-related injuries. The hands, head, or eyes are involved in nearly 75% of these injuries.
- One third of all eye injuries result in permanent blindness.
- Injuries most often happen when a firecracker explodes in someone's hand, is dropped on a foot, or explodes in a pocket.
- Sparklers reach temperatures greater than 1,000 degrees Fahrenheit at the tip and can cause serious burns by igniting clothing.
- Approximately half of all consumer firework-related injuries happen to children under the age of 14.
- Some communities restrict or ban common fireworks. Know your local ordinances.
- Statistics from the Consumer Product Safety Commission show that about 2/3 of fireworks related injuries involve small firecrackers and common household fireworks.

The Fourth of July is a time to celebrate and have fun. To make your holiday "sparkle," take safety precautions to protect you and your family. The Minnesota Safety Council recommends that you:

- Attend only community-sanctioned events. Many communities hold fireworks displays sponsored by fire a department or another safety agency.
- Establish a safe viewing area. The safest place to sit is at least 500 feet away from the staging area.

Summer Heat Safety

Excessive heat during the summer months can pose dangerous risks to your health. Excessive heat is usually high temperatures combined with high humidity levels that persist for two (2) or more days. Here are some tips to help survive the heat and humidity we get here in Minnesota.

Know the difference between Heat Stroke, Heat Cramps and Heat Exhaustion:

- **Heat Stroke** is a <u>very serious condition</u> that requires immediate medical attention - Call 9-1-1! Here are some warning signs:
 - Extremely high body temperature, above 103° F
 - Hot, red, dry skin with NO sweat
 - Rapid, strong pulse
 - Dizziness, confusion and possibly unconsciousness
- Heat Cramps are muscle pains or spasms in the stomach, legs or arms
- Heat Exhaustion is sweating profusely, paleness, tiredness or weakness, headache, nausea or vomiting
 - For both heat cramps and exhaustion, move to a cooler location and remove excessive clothing. Only take small sips of water, and if symptoms don't improve, see your doctor or health care provider.

- NEVER leave children, disabled person or pets locked in a vehicle! There were 33 reported children who died in hot cars in 2022.
- Avoid strenuous activities, especially during the mid-day hours when the sun is at its highest.
- Make sure to stay hydrated with water or sports drinks, and wear light colored clothing.

September is Back to School Time

Even though we are in the midst of the summer months, school will be starting in September. There will be more pedestrian, bicycle and vehicle traffic, especially in the school zone areas. Remember to reduce your speed, buckle up and don't drive distracted.

This goes without saying, but there will be the big yellow school buses. We take numerous calls of vehicles running through the red flashing lights and extended stop arm of these buses. Remember, when you see the yellow lights flashing, it means the bus is going to stop. Slow down and prepare to stop.

2024 Drinking Water Quality Report Now Available

The City of Spring Lake Park is committed to delivering safe, high-quality drinking water to all residents. Each year, we publish a Consumer Confidence Report (CCR) to share the results of water testing and monitoring conducted in accordance with state and federal regulations.

The 2024 Drinking Water Report confirms that our water meets or exceeds all federal and state drinking water standards. Our water is sourced from deep groundwater aquifers and undergoes regular testing for more than 100 potential contaminants. We are proud to report that no violations were found in 2024.

This year's report includes detailed information on lead and copper sampling, fluoride levels, and testing for emerging contaminants. It also highlights the City's efforts to eliminate lead service lines and provides helpful guidance for residents on how to reduce exposure to lead in drinking water.

Emerald Ash Borer Update

The City is nearing completion of the removal of diseased boulevard trees. Remaining trees scheduled for removal are located along Hayes and Garfield Streets. These will be addressed by our contractor later this year and into next year. Trees marked for removal will be identified with a green "X" painted on the trunk.

We are also in the process of grinding stumps and restoring affected areas by adding black dirt and grass seed. Once this restoration work is complete, we kindly ask homeowners to water the newly seeded areas for two (2) weeks to help ensure successful establishment.

Throughout the summer, letters will be sent to private property owners whose trees have been identified as dead or diseased and require removal.

Lawn Sprinkling Regulations

Per Resolution No. 93-17, sprinkling is limited to an ODD/EVEN basis. Properties with addresses that end in an odd number may sprinkle on an odd numbered day. Properties that end in an even number may sprinkle on an even numbered day.

New sod and seed are exempt for a period of two (2) weeks after installation. Properties with a private well are encouraged to follow this same schedule. Uniform compliance throughout the City is less confusing to the public and Code Enforcement Officials. We also encourage you to water your lawn and gardens in the early morning when the water can penetrate the soil without evaporating as quickly. Placing your sprinklers where they will water your lawn and not driveways, sidewalks and streets will also reduce waste.

In addition, check your outside faucets and sprinklers for leaks. It is also a good idea to monitor your summer water usage by reading your water meter on a regular basis. Please keep in mind that meters read in 1,000 gallons. That way if it is a drier summer, you may decide to scale back on your watering to reduce the potential of a big bill in October. The October bill will reflect water usage from July through September.

During especially dry years, additional water conservation measures may be imposed. Check the Blaine/SLP Life, the City's website or the City's Facebook page for any additional watering restrictions.

Recycle Smart

Keep large plastic items out of your recycling cart





Recycle Smart – Do Not Put Bulky Plastics in your Recycling Cart!

It might be tempting to put that broken hamper in your curbside recycling cart or bring your child's large worn toy to the recycling center... it's plastic, so it's recyclable, right? Actually, that IS NOT correct. Curbside programs are set up to sort plastic bottles, cups and containers #1, #2 and #5.

Large, bulky plastic items like children's toys, kiddie pools, lawn furniture, laundry hampers, plant pots, buckets and other large plastic household items, should not be put in a curbside recycling cart. Drop-off centers don't want them either because they ARE NOT recyclable.

If not damaged, consider reuse and donate these types of items. If damaged, contact your trash hauler before throwing away to see if there is a charge for disposal.

> Reuse or donate these items if they are not broken. If they are broken, they ARE NOT recyclable and must be put in your trash.

City Hall Recycling Drop-Off

Spring Lake Park offers a FREE recycling drop-off program for all Spring Lake Park residents. The drop-off site is located inside the Link at City Hall and is available to residents Monday through Friday from 8:00 AM-4:30 PM.

Accepted Items:

- Cell phones (with or without batteries)
- Laptops, iPads, tablets
- PC's (computer towers)
- Hard drives
- Holiday string lights
- Small hand-held electronics
- Gaming consoles (Xbox, PlayStation, etc.)
- Ink Cartridges
- Batteries (single-use and rechargeable)
 - There is a separate container for batteries located in the Link area. Please do not place batteries in the Electronics container.



Cleaner Roads, Cleaner Water

Earlier this year, Spring Lake Park acquired a new street sweeper. The \$300,000 specialized vehicle was entirely funded by grants from the Clean Water Fund and the Coon Creek Watershed District. Street sweepers help keep our roadways clean and reduce wear and tear on city infrastructure. However, street sweepers also play a big role in protecting the health of our local waterways.

Street sweeping is one of the most cost-effective and efficient ways of reducing water pollution. The storm drains that line our roadways connect directly to our local creeks, rivers, and wetlands. This connection to local waterways helps reduce flooding during storms and snowmelt. However, it also means that any debris, trash, or chemicals that enter a storm drain will end

up in our water. This is called stormwater pollution.

Street sweeping helps reduce stormwater pollution by removing pollutants from the roadways before they can be washed into storm drains. A street sweeping study conducted by Coon Creek Watershed District prior to the purchase of the street sweeper suggests that the new sweeper will help keep 43 pounds of phosphorus and 1.3 tons of sediment from polluting our local waterways every year. For reference, just one pound of phosphorus has the potential to support up to 500 pounds of algae growth!

You can do your part in reducing stormwater pollution by following these helpful tips:

- 1. **Only rain down the drain.** SLPC 9.20.020 prohibits anything other than water from entering the streets or storm drains.
- 2. Keep grass clippings and leaves out of the street. Always compost, bag, or mulch your yard waste. Yard waste contains phosphorus, which encourages algae growth.
- 3. **Trash the poo, not our water.** Always pick up pet waste and dispose of it in the trash.
- 4. **Adopt a storm drain.** Visit *mn.adopt-a-drain.org* to adopt a drain in your neighborhood.
- 5. **Report illegal dumping.** If you see anyone spilling, dumping, or disposing of materials into a storm drain or on the street, report it immediately to the Public Works department at 763-784-6491.
