  Where Can Candidates Campaign?

It is unlawful for a person to deny access to an apartment house, dormitory, nursing home, manufactured home park, other multiple-unit facility used as a residence, or an area in which two or more single-family dwellings are located on private roadways to a candidate who has filed for election to public office or to campaign workers accompanied by the candidate, if the candidate and workers seeking admittance to the facility do so solely for the purpose of campaigning. *This information was taken from Minnesota Statutes 211B.20* 

A violation of this section is a petty misdemeanor. There are some exceptions to this law. Exceptions allowed under this provision include:

- 1. Denial of admittance into a particular apartment, room, manufactured home, or personal residential unit;
- 2. Requiring reasonable and proper identification as a necessary prerequisite to admission to a multiple-unit dwelling;
- 3. In the case of a nursing home, denial of permission to visit certain persons for valid health reasons;
- 4. Limiting visits by candidates or workers accompanied by the candidate to a reasonable number of persons or reasonable hours;
- 5. Requiring a prior appointment to gain access to the facility; or
- 6. Denial of admittance to or expulsion from a multiple-unit dwelling for good cause.

# **Absentee Ballot Services**

Spring Lake Park residents who are unable to go to their polling place on Election Day may cast an absentee ballot by mail or in-person during the 46 days prior to the election.

Voters who prefer to cast their absentee ballot in-person may do so at the Spring Lake Park City Hall during the hours of 8:00 AM to 4:15 PM, Monday through Friday. In-person absentee balloting will also be available at City Hall on the Saturday, October 26 from 9:00 AM until 3:00 PM, Tuesday, October 29 from 8:00 AM until 7:00 PM, Saturday, November 2 and Sunday, November 3 from 9:00 AM until 3:00 PM and until 5:00 PM the day before the election, Monday, November 4.

Voters who live in Anoka County and wish to vote absentee by mail, can download the absentee ballot application any time at *www.anokacounty.us/absenteevoting* or they may call 763-324-1300 to have an absentee ballot application sent to them.

Voters who live in Ramsey County and wish to vote absentee by mail, can download the absentee ballot application any time at *www.co.ramsey.mn.us/elections/absentee* or they may call 651-266-2171 to have an absentee ballot application sent to them.


- Heard a report on the 2023 audited financial statements. Accepted the 2023 audited financial report.

#### Where to Vote for 2024 General Election

In-person voting will take place at Emmanuel Christian Center, 7777 University Ave NE, Spring Lake Park on Tuesday, November 5 from 7:00 AM – 8:00 PM.

Precinct 1A and 1R will be located closest to door 2. Precinct P-2 will be located closest to door 4.

# **Voter Registration**

#### To vote you must be:

- A U.S. citizen
- At least 18 years old on Election Day (16 & 17-year olds can pre-register)
- A resident of Minnesota for 20 days
- Not currently incarcerated for a felony conviction
- Not under a court order that revokes your right to vote

# 1. Register Online or Update Your Registration at *www.mnvotes.org*.

It's quick and easy to register online. You will need the following:

- Your Minnesota driver's license or Minnesota identification card number, or the last four (4) numbers of your Social Security number
- An email address
- Be eligible to vote in Minnesota
- You will need to re-register if your name or address changes.

#### **Other Ways to Register:**

- Use a paper form. Download a voter registration form to print, complete, and return to your local elections' office.
- **Register when you vote**. In Minnesota voters can register at polling places on Election Day or early voting locations before Election Day. To register on election day you will need to bring one of the the following:
  - ° ID with current name and address
  - Valid Minnesota driver's license, learner's permit or ID; or a receipt for any of these.
  - ° Tribal ID with name, address, photo and signature.

# 2. Photo ID and a document with current name and address:

# APPROVED PHOTO IDS (CHOOSE ONE)

#### The ID can be expired.

- Driver's license, state ID or learner's permit issued by any state
- U.S. Passport
- U.S. Military or Veteran ID
- Tribal ID with name, signature and photo
- Minnesota university, college or technical college ID
- Minnesota high school ID



#### **APPROVED DOCUMENTS (CHOOSE ONE)** *Can be shown on electronic device.*

- Bill, account or start-of-service statement due or dated within 30 days of the election for:
  - <sup>o</sup> Phone, TV or internet
  - ° Solid waste, sewer, electric, gas or water
  - <sup>°</sup> Banking or credit card
  - ° Rent or mortgage
- Residential lease or rent agreement valid through Election Day
- Current student fee statement

#### Registered voter who can confirm your address

A registered voter from your precinct can go with you to the polling place to sign an oath confirming your address. This is known as 'vouching.' A registered voter can vouch for up to eight voters. You cannot vouch for others if someone vouched for you.

#### Photo ID with student housing list

Colleges and universities that enroll students accepting state financial aid must send election officials a student housing list. This list includes students who live on-campus and those that have provided their current address to the school and live in the city where campus is located. If you are on the list, show any form of photo ID listed in step number two (2) to complete your registration.

#### Valid registration in the same precinct

If you are registered in the precinct but changed names or moved within the same precinct, you only need to tell the election judge your previous name or address.

#### Notice of Late Registration

If you registered to vote within 20 days of the election, you may get a Notice of Late Registration in the mail. Bring it with you and use it as your proof of residence to register.

#### Staff person of a residential facility

If you live in a residential facility, a staff person can go with you to the polling place to confirm your address. This is known as 'vouching.' A staff person can vouch for all eligible voters living in the facility.

The staff person must prove their employment at the facility. There are several ways to do this, including by showing an employee badge. Learn more about voter registration in residential facilities here: *https://www.sos.mn.gov/elections-voting/register-to-vote/im-in-a-residential-facility/*

- 3. Minnesota Secretary of State: Visit the Secretary of State website at <u>www.sos.state.mn.us/elections-voting/</u>. On this site you will find out how to register to vote, where to vote and what is on your ballot.
- 4. Early Voting Locations: Early voting is available in Spring Lake Park, at the City Hall from 8:00 AM 4:15 PM.
- 5. Stay Informed: Keep yourself updated on any changes to polling places or voting procedures. Visit official websites, follow local news, and subscribe to newsletters or notifications from the City or County elections office.

# City of Spring Lake Park Proposes 2025 Budget and Property Tax Levy

At its September 3, 2024 meeting, the City Council approved the 2024 preliminary tax levy to fund the proposed 2025 budget.

The proposed 2025 General Fund budget shows an increase of 6.13%, with the General Fund levy proposed to increase by 5.38%, from \$3,823,887 to \$4,029,435. This increase aims to maintain essential services while addressing the growing needs of our community.

The Capital Improvement Plan levy is proposed to increase by 5%, from \$183,560 to \$194,591, to ensure the continued purchasing power of our Equipment Fund. Additionally, the property tax levy for the City's share of the 2022 Street Improvement project will remain steady at \$24,078, while a new levy for the City's share of the 2024 Street Improvement project is proposed at \$28,421 per year for the next ten (10) years.

City Administrator Daniel Buchholtz explained the reasoning behind these changes: "The proposed increase in the General Fund levy is necessary to support the City's ongoing commitment to public safety, infrastructure, and community services. The City Council's goal is to maintain the quality of life for all residents while ensuring fiscal responsibility."

A significant factor affecting the overall tax levy is the increase in debt service for the 2025 fiscal year. The debt service levy is set to rise from \$80,000 in 2024 to \$444,747 in 2025, entirely due to the debt service for the City Hall Renovation/Expansion project.

The overall levy for 2024, collectible in 2025, is proposed to increase by 14.78%, from \$4,113,290 to \$4,721,272.

"We understand that any increase in property taxes is a concern for residents," stated Administrator Buchholtz. "However, this proposed budget is carefully crafted to balance the needs of our community with the City's long-term financial health. We are committed to being transparent and responsible stewards of public funds."

Residents are encouraged to participate in the budget process. The annual Truth in Taxation hearing will take place at 7:00 PM on December 2, 2024 at the Able Park Building, 8200 Able Street NE, offering an opportunity for residents to provide input and learn more about the proposed budget. The final budget will be approved at the December 16, 2024 City Council meeting.

# MnDOT Wants Your Input on Conceptual Designs to Make University Avenue (Highway 47) Safer and Easier to Use.

The Minnesota Department of Transportation (MnDOT) is seeking to transform the 7-mile stretch of Highway 47 between 37th Ave. in Columbia Heights and just north of 85th Ave. in Blaine. A previous study determined this segment of University Avenue to be crash and accident prone, and <u>redesign</u> is necessary for safety. MnDOT wants to make sure everyone can use University Avenue safely and comfortably, whether they walk, roll, bike, use public transit, or drive a vehicle or truck.

Collecting information on the public's experience and needs is critical to understanding how each intersection design concept along University Avenue can better serve all users. MnDOT wants to know how proposed roadway changes impact you, what concerns you have about safety and what changes are most important to you. MnDOT invites all residents, business owners, commuters, and community members to visit the study website at *https://bit.ly/Hwy47North* and share feedback.

#### CODE ENFORCEMENT



#### What is Nuisance Activity, You May Ask?

In a nutshell, nuisance activities are those that can and do affect the quality of life for residents.

Many of the code-related reports that are received relate to nuisance violations, which are generally neighbor to neighbor and, often in residential areas. However, they can also crop up in commercial or mixed-use areas.

The goal of Code Enforcement is compliance, **NOT** enforcement. Being a "good neighbor" can head off complaints before they get out of hand and come to the attention of the City or create ongoing tensions between

neighbors. Communication is a key factor, so the goal is to get neighbors to communicate with each other, whether it's discussing property issues or other difficult topics.

**Picture this**: A Code Enforcement Officer suddenly shows up on your doorstep to discuss the unruly vegetation in your front yard. While our Code Enforcement Officers are very friendly, this can catch people off guard and the initial reaction may be, "Oh no, I'm in trouble and am going to be fined." **AND** "Did my neighbor report me?"

**Now... Picture THIS**, instead. Your neighbor's vegetation is getting out of hand. You have already introduced yourselves to each other by waving or saying "Hi" when you pass, or you've taken the time to know your neighbor's name. That personal touch can be the difference between a nuisance complaint and the following:

"Oh, I'm sorry my grass is so out of control. My spouse is often away for work and usually handles the yard work. I have three kids and a full-time job, so my free time is limited". NOW—You as a good neighbor might be able to offer, "Hey, I have a strong and energetic teenager who could easily mow your yard for \$10.00! He also receives credit from his Boy Scout Troop for his community involvement".

To summarize: nuisance violations are generally easier to remedy when addressed early on and before they become an insurmountable and overwhelming task. Our Code Enforcement Department is always happy to speak with residents and, together, come up with creative solutions to a problem.

Remember: Communication is essential to being the neighbor you would like to have.

# Help Keep Fire Hydrants Clear This Winter

As we prepare for the winter season, we'd like to remind residents of the importance of keeping fire hydrants clear of snow. In the event of a fire, every second counts, and a snowcovered hydrant can delay emergency response. Please take a few extra minutes when shoveling or snow blowing to clear at least three (3) feet around



any fire hydrant near your home. This simple act can make a huge difference in keeping your neighborhood safe and ensuring firefighters have quick access in an emergency.

# **Do Not Deposit Snow in Public Streets**

As a reminder, according to **State Statute 160.2715**, it is prohibited to deposit snow onto public streets. This regulation is in place to help ensure the safety and accessibility of our roadways for everyone in the community.

We kindly ask all residents and property owners to refrain from moving or depositing snow onto city streets when clearing driveways, sidewalks, or other areas. Your cooperation in following this regulation will help keep our streets safe and clear for snowplows and emergency vehicles.

#### **PUBLIC SAFETY**

#### **Fire Safety**

Bonfire season will soon be here! Be safe when it comes to enjoying your bonfire this fall. Make sure to keep your open fire 20 feet from any structure, and a portable fire pit 15 feet from any structure. State Fire Code and City Ordinance require you to have a fire extinguisher or hose ready to put out the fire, and you must also be in constant attendance. Remember to obey any fire warnings or burning bans as well.



307.4.2 Recreational fires. Recreational fires shall not be conducted within 25 feet (7620 mm) of a structure or combustible material. Conditions which could cause a fire to spread within 25 feet of a structure shall be eliminated prior to ignition.

**307.5** Attendance. Open burning, bonfires, recreational fires and use of portable outdoor fireplaces shall be constantly attended until the fire is extinguished. A minimum of one portable fire extinguisher complying with Section 906 with a minimum 4-A rating or other *approved* on-site fire-extinguishing equipment, such as dirt, sand, water barrel, garden hose or water truck, shall be available for immediate utilization.

307.3 Extinguishment authority. When open burning, a recreational fire or a portable outdoor fireplace creates or adds to a hazardous situation, or a required permit has not been obtained, the fire code official is authorized to order extinguishment.

# **Neighborhood Safety**

Lighting can be a deterrent for potential criminals. One way to help deter criminal activity is to leave your front lights on or have a motion sensing light in the overnight hours. Another lighting consideration is the street lights in your neighborhood. We know that there are some lights that are out. You can help by reporting the light fixture that is out to Xcel Energy. There is a website (*https://mn.my.xcelenergy.com/s/outage-safety/reportlighting-outage*) where you can enter in information on which

light pole and its location. Xcel Energy is fairly quick to respond and repair the lights. If you notice the light out, please help out by completing the online information.



# **Suspicious Activities Awareness**

You've likely heard the old adage, "Nothing good happens after dark." In some ways, it holds true, especially when it comes to incidents like thefts, burglaries, and other illicit activities that tend to occur during the nighttime hours. Therefore, our dedicated police force remains vigilant, actively monitoring individuals exhibiting suspicious behavior. Whether it's individuals or vehicles lingering around closed businesses or loitering in residential areas, our officers are trained to identify reasonable suspicion and initiate contact. Our primary aim is to prevent crimes before they happen. If you ever observe anything that raises suspicion, please do not hesitate to dial 911, and an officer will promptly investigate the area. Your cooperation plays a crucial role in maintaining a safe community. You are our eyes and ears throughout the community!

# Winter Weather Reminders

Although some of us hate to admit it, the days are growing shorter along with the weather becoming colder. The Spring Lake Park Police Department would like to remind residents of a few items for winter safety and security.

- As the days get shorter, leaving a porch/patio light on or having motion sensing lights are a great way to deter the crimes of opportunity during the dark hours. Also make sure to secure your garage doors, especially before going to bed. Criminals have entered homes through open garage doors. If you are confused about light or locks, please call the police department to schedule a safety survey.
- Never leave your vehicle unattended while it is running. Auto thieves take this as an opportunity to steal your vehicle. This also goes for those with remote start as some thieves have learned how to defeat the safety features.
- Any time there is precipitation (fog, mist, rain, sleet, snow, etc.) in the air, drivers **MUST** turn on their headlights when operating on any roadway. Although your vehicle may be equipped with auto-sensing headlights, they may not turn on. Manually turning on your lights also ensures your taillights are also on so you are visible to other drivers.
- As the holiday shopping season begins, do not leave your purchases in your vehicle. If you must do so, make sure they are locked in the trunk or hide them from view.
- Remember, no ice is ever truly safe. Please don't venture onto our lakes and ponds without checking the thickness and having proper gear.
- Last but not least, November 1 is the start of the seasonal parking restrictions, and it continues until March 31. City Ordinance 7.08.020 subd. E states there is no overnight parking between the hours of 2:00 AM and 8:00 AM. It also includes no parking on any street following a snowfall

of three (3) inches or more, regardless of the time of day, until the street has been plowed curb to curb.

# Additional General Safety Tips and Helpful Reminders

- Furnace Check Up As winter approaches, now is a great time to have your furnace checked. It is a good idea to have your furnace running safely and at peak efficiency. Also, do not forget to check your fire alarms and carbon monoxide detectors to make sure they are working properly. When you change your clocks, change the batteries in those detectors.
- **Mailbox Safety** Place your outgoing mail in an official US Post Office collection box. Never leave outgoing mail in your curbside mailbox with the flag up. This can be an invitation for identity thieves to come and remove the mail and gain access to your personal information.
- **Remove Your Valuables** Remember to always remove your valuables such as cell phones, cameras, purses, garage door openers and anything of value from your vehicle, especially if it is going to be left out overnight.
- **Driving in Snow** Even though we're "Minnesotans," it seems that the first snowy driving experience takes us by surprise. Remember to slow down and plan extra time to reach your destination. Stopping distances are severely increased and acceleration capabilities can be unpredictable.
- Vehicle Check Give your car a winter checkup. Make sure you have good tires and brakes. Test your heater and

defroster for proper working order. Check for worn out windshield wipers and low windshield washer fluid. Be sure to put your scrapers & brushes in your vehicle to clear windows of snow and ice. If you plan on winter travel, make sure you have a



winter survival kit in your car including extra blankets, boots & gloves, etc..

# **December is National Impaired Driving Prevention Month**

Every president since 1981 has proclaimed December as National Drunk and Drugged Driving Prevention Month or Impaired Driving Prevention Month. With the celebrations and festivities between Thanksgiving and New Years, The National Association of Drug Court Professionals describe this as "one of the deadliest and most dangerous times on America's roadways due to an increase in impaired driving." The Minnesota Department of Public Safety stated during the 2022 holiday extra enforcement DWI campaign, there were 2,228 DWI arrests across Minnesota. 

# **ANNUAL NOTICE - For Military Personnel**

Minnesota law requires that utility providers make utility payment arrangements available to military service personnel in the following situation: A member of a household has been issued orders into active duty, deployment, or has had a change in duty station as long as the residential customer meets specific income criteria and completes the application process. An application must include copies of income statements and proof of military orders as described in the law. A utility provider may

shut off utility service for nonpayment if an application does not include the required copies of income statements and proof of military orders as required by Minn. Stat. § 325E.028. Please contact

# **Certification/Tax Lien of Delinquent Utility** Fees

City Staff will be reviewing water utility accounts to refer to the City Council for their approval to certify unpaid delinquent balances to the County Auditor. If you are in receipt of a notice from the City, prompt payment would be appreciated. All delinquent accounts certified to the county will be assessed an

additional \$125.00 administrative fee. Certification may also include unpaid citations and (or) service invoices.



# **Preparing to Protect Your Water Meter During The Winter Months**

Minnesota's cold weather temperatures threaten to freeze water meters and pipes. The following are a few tips to take to avoid the disaster of a frozen meter:

- Make sure warm air is allowed to circulate around your water meter and is free of obstruction. Keep in mind the coldest air is near the floor and along the walls of a basement.
- If your water meter is in a separate room, leave the door open to this room to allow warm air to circulate.
- Keep cabinet doors open if your water meter is inside a cabinet.
- If the water meter is in a crawl space or garage, you may want to consider adding insulation.

# Here are some additional tips to prevent pipes from freezing:

- Insulate any exposed pipes. Be sure to protect pipes with northern exposures, and wrap with UL-approved heat tape. Note: Improper use of heat tape or pipe insulation can cause a fire, so be sure to follow the manufacturer's instructions.
- Keep thermostats set to at least 55 degrees if you plan to leave your home for any amount of time or go on vacation. It is also a good idea to have someone check on the home while you are away and make sure it is staying warm enough to prevent pipe freezing.
- If you plan to be away for a long period of time, drain and shut off the water system completely, except indoor fire sprinkler systems.
- Open cabinet doors under your kitchen and bathroom sinks to allow the heat inside your house to keep your pipes warmer. Keep basement or crawl spaces warm enough to prevent freeze-ups.
- Turn on water faucets and allow hot and cold water to trickle at night from sinks inside your home, especially those located on an exterior wall.

# If in the coming winter months you experience a frozen water meter or water line:

- Make sure you and your family members know how to shut off the water in case pipes burst.
- Be careful of the potential for electric shock in and around standing water.
- Never try to thaw a pipe with an open flame or torch.
- Call the City at 763-784-6491, Monday Friday, between the hours of 8:00AM to 4:30PM. The Public Works Water Department may help you choose the best way to "thaw it out" and get it working again or you may need to contact a licensed plumber. If the meter is damaged, property owners are responsible for paying for the new meter which can cost between \$155.00 to \$215.00.

Following these few tips will help avoid an unpleasant surprise and a costly repair.

# **Fall Street Sweeping**

Street sweeping is expected to begin the first week of November, weather permitting. It is very difficult for the driver of the sweeper to see all of the activity around them, so please maintain a safe distance from the street sweeper.

# Winter is Coming!

Ready or not, winter is coming. Keeping city streets and sidewalks clear of snow and in safe driving condition is an essential service of the Spring Lake Park Public Works Department. The clearing of residential streets is determined by weather conditions.

The Public Works Staff are concerned about persons, particularly children, near the road and vehicles following too closely behind them as they go about their task of keeping Spring Lake Park streets in good traveling condition. Often times, there are winter snow conditions when the driver must stop his forward motion and back up before continuing on, particularly at intersections. Following too closely can cause an accident. Always exercise extra caution near or around the snowplows.

Here are some additional tips to make everyone's winter much safer:

- Obey parking regulations.
- Slow down slick pavement reduces traction and can cause loss of control of your vehicle.
- Increase your following distance, use headlights and wear vour seatbelt.
- Apply anti-lock brakes steadily.
- Use caution near snow plow equipment, staying at least 50 feet away to reduce the risk of accidents.
- Allow for snow removal equipment's wide turns at intersections.
- Winterize vehicles: check brakes, tires, battery, wiper fluid and wipers.
- Pay attention to weather advisories and leave home earlier than usual.

#### Mailboxes

This is a good time to check the condition of your mailbox/post to determine if it meets installation requirements. The base of the box should be 48-50" above street level. The post should be 20" back from the curb. The face of the mailbox should line up with the curb.

The snowplow wing needs 48" of height clearance to avoid hitting the box and the 20" from the curb to clear the post. The City does **NOT** assume liability for mailboxes damaged during plowing operations, unless it is determined the plow made direct contact with a mailbox that is properly installed using the standard 4" x 4" post and metal box requirements. Decorative mailboxes are not within the requirements and will not be replaced if damaged. The mailbox should be secured to the base and post and the post securely in the ground; no rotting wood. There should not be any plastic newspaper tubes or attachments to the mailbox below the 48" minimum height requirement.




# **Snow Removal from Private Property**

Minnesota State Law and City Code prohibit removing snow and ice from private property, including driveways and parking lots, to a roadway, across a roadway or onto a sidewalk or adjacent property.



into the road or right-of-way: It's illegal to push snow into or across roadways and rights-of-way. This can create a hazard for people traveling the road, such as drivers, bikers and snow removal equipment operators, and can create liability issues for the property owner.



# Where Should You Place Trash/ Recycling **Bins on Pickup Day?**

Winter snow accumulations can pose a challenge when it comes to trash/recycling pickup, so where should you place your bins on pickup day? Trash/ recycling bins should be placed at the end of your driveway no further than three (3) feet from the curb. Do not put your bins in the street as this creates a hazard to plow trucks and other passing vehicles. Avoid placing your bins on top of snow piles as the shifting and melting of snow could cause your bins to tip over. The unlevel surface can also make it difficult for the garbage trucks to put your bins back down properly. You may need to clear a level space for your bins to sit safely on pickup day.

# Leaves! Leaves! Leaves!

"Leaf" it to nature to break down your leaves by mowing them finely so your grass can use them as natural fertilizer and You can save time and money on fertilizing, raking, or blowing.

If you keep leaf piles for the kids to jump in, afterwards use the leaves as mulch for your flower beds or recycle them other ways:

- Check with your garbage hauler for proper leaf disposal. It is illegal to put yard waste in with your garbage.
- Take the leaves and other yard waste to a county compost site where up to four (4) cubic yards is no charge (One (1) cubic yard = approximately five (5) to eight (8) yard waste bags, so 20-40 bags are free).

#### Reminder: Out of the Street, Pond, and Creeks!

Please keep all leaves out of the street since they can clog storm

drains or add pollution to our waters. City street sweepers are out to collect sand and dirt that needs to be vacuumed up from streets. Leaves lower the ability of the sweeper to collect the sand & dirt, which are pollutants for our creeks.

A recent study has shown street sweeping can effectively and highly reduce these pollutants if done strategically. You can also help by adopting a storm drain through *adopt-a-drain.org* where you get to name your drain, get swag, and join over 10,000, ether Minnesotane in pro-



over 10,000 other Minnesotans in protecting our waters.

Leaves (and grass clipping piles!) need to also be kept out of or adjacent to creeks, ponds, ditches, and wetlands. Why? Leaves can add excess phosphorus to our creeks, ponds, and lakes. Excess phosphorus leads to algal blooms that can cause fish die-offs. Piles of grass clippings and leaves also kill the vegetation below, causing erosion.

By mulching your leaves and grass clippings with your mower, you save time, feed your lawn, protect property by reducing potential flooding sources, and protect our waters!



The City of Spring Lake Park **WILL NOT** be accepting leaves, clippings or brush for composting until Spring 2025 due to construction. If you need to dispose of composting materials, please contact Bunker Hills in Coon Rapids at 763-767-7964 or Rice Creek in Lino Lakes at 651-429-3723 to inquire about hours and potential cost for disposal.

# **Clean Water Starts at Home**

We want to remind you that come the snow and ice, to shovel first and early. Using chloride products to melt ice on your sidewalk and driveway is not the best way to deal with icy areas around your home. Salt products can corrode your vehicle, cause pitting or spalling of concrete, and run off into our lakes (and ponds and creeks) when melting. Once salt gets into our waters it is nearly impossible to get out; only reverse osmosis works.

City staff get training on this topic regularly. Still, we are seeing salt levels too high in some of our local waters. Here are ways for you to have safe walking areas, reduce salt/chloride pollution, and maybe save some money:

- Shovel snow **during** a snowstorm instead of waiting until the end. Start with the very first snow and keep up the rest of the winter, especially in shaded walkways.
- Think "anti-icing." The goal is to break the bond between ice and pavement just where you need it so it can be shoveled or plowed (as opposed to melting everything).
- Treat **before** a storm to help prevent ice buildup so less de-icer is needed.
  - Alternatives: use Sand for traction only safe and effective. Remember to sweep up any excess and reuse. You can do this for salt products, too.
- After storms; use as little de-icer as possible:
  - Sand safest for pets and children (sweep up any excess). The pet-safe products usually have urea in them which adds nutrient pollution and so can cause algae blooms.

Remember, regular salt (sodium chloride) is not effective at temperatures below 15 degrees (F). For colder temps, try sand... or pre-treat with a salt brine like cities are doing.

# Using Salt Safely This Winter

The Salt Ghost is back to remind you to use salt wisely. Even

when preparing for snowstorms the goal is to aim for about three (3) inches between salt granules. This maximizes melting while reducing the amount of salt that can haunt our waters. More salt does not always mean more safety.

The Household Hazardous Waste Facility accepts many materials that should not be put in your recycling or trash carts. Besides pesticides, painting and refinishing products, you may not realize that the following materials are also accepted:

- Automotive Products (antifreeze, gasoline, used motor oil and used oil filters)
- Fluorescent Bulbs (including HID and CFL's)
- Household Batteries (alkaline, lithium ion, cell phone, power tool, button and rechargeable batteries)
- Lead tackle
- Sharps (syringes, lancets, used EpiPens®, hypodermic needles, pen needles and IV needles) Sharps must be placed in a rigid, puncture-resistant plastic container.
